BRIDE - WEDDING DAY

There are many different ways to create a wedding day contract...from the very simple to very complex. There is no right or wrong, however my suggestion is that you make it as simple as possible while still making sure that all of the most pertinent information is included.

At Hair Comes the Bride, we would have the stylist complete the contract with the bride and simply have her sign. I know that many of you may choose to email the contract to the bride and have her fill it out herself. Again, there is no right or wrong...it is what works for you.
